Synopsis

Narrative

On Tuesday, December 23, 2025, Camille Lowman sent Chief Price an email containing information that she believed was relevant to this investigation. The email contained an attachment titled, "Attachments A 1 to 12 B 1 to 2 C 1 to 3.pdf."

Later that day, she sent a second email, stating, in part:

Lt. Olsen,
Thank you for confirming receipt of my emails. I really appreciate your confirmation of my email.

Chief Price,
Angie Bunda actually worked for a police chief here in the area a few years ago and shared with me that the police chief had a saying, "No call too small." I understood that to mean that no one reaching out to law enforcement should be ignored. Unfortunately, it appears that Angie and I have a "call" that you consider to be "too small."

I say this as it appears that a request for a status on a matter where we have engaged in reporting of public corruption and of a subsequent action by a speaking agent of the Evergreen School District has engaged in providing false statements to a public servant...and this apparently doesn't merit a response.

There are many taxpayers in the City of Vancouver (including myself) who I sincerely believe will be surprised (and disappointed) by this reality.
And unfortunately, I imagine there are others who sadly won't be suprused (but will be equally as disappointed).

Given that we are going to be ignored, we will move on to interact with those who are more directly accountable to the voters. We do also sincerely hope that you are not neglecting to respond to the "calls" of others in the way you have been choosing to ignore ours.
